

Nature and Purpose of the Canadian Paraplegic Association (Manitoba) Inc.

CPA (Manitoba) Inc. is a non-profit organization representing persons with spinal cord injuries (SCI) in Manitoba. Accountable to a membership comprised of persons living with these disabilities, their families and supporters, CPA employs professional staff, uses committed volunteers and encourages peer-linkages to achieve its mission.

CPA's Core Services

CPA (Manitoba) Inc. operationalizes its Mission through CPA's Rehabilitation Services Framework and the delivery of six Core Services.

Rehabilitation Counselling

Professional counselling services assist individuals in their return to an independent life in the community. CPA offers continuous support, information, community links and follow-up.

Service Coordination

A unique framework ensures overall coordination for the rehabilitation process, from onset through community integration.

Vocational/Employment Services

These services assist individuals to identify vocational options and obtain employment consistent with their values, skills, abilities and interests.

Peer Support

"Someone who's been there" can act as a mentor and role model to encourage and sustain others through the challenges they face.

Community Advocacy

CPA strives to create a society based on inclusiveness. These efforts involve identifying, reducing and working with others to eliminate barriers to full community participation, including leadership in prevention efforts.


Information Services

CPA provides comprehensive and relevant information for stakeholders that include individuals with spinal cord injuries, their families, employers, community agencies, insurers and governments.

What is Spinal Cord Injury?

SCI is damage to the spinal cord whether it occurs by physical trauma, illness or disease. The spinal cord is the neural tissue in the spinal canal that connects the brain to the body below the head. This neural tissue cannot normally regenerate, thus damage to it is considered permanent

- A person with *paraplegia* has paralysis in the lower extremities and part of the torso
- A person with tetraplegia has, in addition, a partial or complete paralysis of the hands and arms due to a spinal cord injury in the neck area.

Since 1946, CPA has been active in Manitoba. The Central Western Division of CPA was formed in 1946 at Deer Lodge Hospital in the form of a 37 member club organized and headed first by Eric Lyle, and then A.T. (Tony) Mann. In August of 1946 the first formal board meeting was held, and over the past 60 years, CPA (Manitoba) Inc. has been hard at work to champion the rights of persons with disabilities while providing holistic rehabilitation services, as well as information and advocacy for the newly injured and their loved ones. Throughout 2006 CPA (Manitoba) Inc. will be celebrating the past 60 years, and looking ahead to 60 more.

President and Executive Director's Report

The last year has been one of Changes, Challenges and Celebration. The Board of Directors continued to focus on its three strategic initiatives: enhancing public image, expansion of services and professionalism.

The development and execution of activities in support of these initiatives is a direct result of the hard work of: the Board of Directors through its involvement in the Programs & Community Relations Committee and the Operations Committee: staff through their dedication to providing quality services; and staff and volunteers who serve on other community committees and contribute so much to this organization.

During the past year:

- The CPA 60th Anniversary ad-hoc committee has planned an Anniversary Dinner Celebrating 60 Years of Achievement. Set for the fall of 2006, this event will showcase the history and accomplishments of the Association while honouring individuals who have made the last 60 years of service and excellence possible.
- The successful sustainment of fund development activities such as the Chocolate Almond Program. It has exceeded our financial goal and the program will be expanded with the introduction of an additional representative in the coming year.
- The ongoing participation in the Rick Hansen Solutions in Motion Alliance within Manitoba.

We have faced challenges that have required flexibility and innovation in order to continue to maximize our quality of services. We will continue to respond to these and other challenges.

- The Brandon Walk 'n Roll fundraiser has become a biannual event as the organizing committee continues to sustain itself within the limited resources in the Westman Region.
- Changes in staff included new Executive Director. Communications and Public Education Coordinator and Rehabilitation Counsellor for Aboriginal Services positions.

The Association is now operating with a full complement of staff. We thank all staff and volunteers for their dedication and commitment through this transi-

- The planned relocation of the Health Sciences Centre Spinal Cord Injury Unit to the Riverview Health Centre has required thoughtful and constructive input from CPA to ensure that the concerns for quality service delivery are being understood and addressed. We have developed and delivered a response to this planned move that has encompassed a comprehensive perspective of the issues facing individuals with spinal cord injury as they progress through their rehabilitation.
- Our CPA National Office has seen a significant turnover in staff. The National Board of Directors in conjunction with National Office staff has embarked

on a reorganization of the roles and priorities of the National Office as it strives to strengthen its organizational and financial structure.

The coming year will afford opportunities for the Association to celebrate its accomplishments as well as to address ongoing challenges.

- Continue to provide input to the Winnipeg Regional Health Authority regarding our perspective on the issues involved in the planned move of the Health Sciences Centre Spinal Cord Injury Unit.
- Support our National Office as it hires a new Executive Director and moves forward through the operational phase of its reorganization.
- Proactively consider how to prioritize our service delivery configuration as demand for service increases and funding levels continue to be outpaced.
- Continue to balance prudent fiscal management with the commitment to professionalism to ensure quality _ service.
- Continue to acknowledge and support our team of professionals to ensure retention of a dedicated staff and the provision of consistent, professional service.

We thank our funding partners, sponsors and supporters for their continued financial commitment. We thank our current and retiring board members for their guidance and valuable contribution to our Association. We commend our team of dedicated staff and volunteers for their caring commitment to delivering services that improve the lives of persons with spinal cord injury.

Treasurer's Report

On behalf of the Board, I am pleased to report that the 2005/2006 year ended with an Excess of Revenue over Expenses of \$29,773, including a transfer to the Manitoba Paraplegia Foundation Inc. of \$60,000.

We intend to use these funds in the future to bring expanded service to our clients.

Our Total revenue increased by \$41,000 which is made up of numerous variances in funding and can be referred to on page 7 of the Audited Statements which indicates that all of our major funders increased their support.

Our expenses set out on page 8 of the Audited Financial Statements decreased by \$63,712. This was caused primarily as a result of an unbudgeted reduction of Salaries due to staffing changes and the difficulty of timely replacements. The rest of the expenses with few variances were basically consistent with the prior year.

We wish to extend our sincere gratitude to our funders, members and donors for their continued support of CPA's programs and services.

I wish to thank our Accounting Officer, Roslyn Dooley for her hard work and dedication, and thank Bruce Jack and Gabriella Zaporozan of Deloitte & Touche LLP for their services in the preparation of our Audited Financial Statements.
